Joint Auditor of Court for Lothian and Borders.

As you may be aware, your colleague, Frank McConnell, has advised me that he will be resigning from the office of Joint Auditor at the end of October this year. The arrangements for the auditing of judicial accounts of expenses are currently under review and, of course, traditionally Edinburgh and Glasgow were the only Sheriff Courts where Auditors were appointed by the Sheriff Principal and were respected members of the legal profession. Otherwise, judicial auditing was conducted by the Sheriff Clerks. Clearly, the Sheriff Clerks in Lothian and Borders have not required to develop auditing skills and it will be necessary to consider how auditing will be conducted in the future.

SCTS are in the course of training Sheriff Clerks in the skill and art of auditing with a view to putting in place certain reforms which the Scottish Government wish to implement.

In these circumstances, I am mindful that you have given the administration of justice the benefit of your significant experience as Joint Auditor for more than 30 years this may be a timely opportunity to consider how the process of taxing accounts of expenses occurred in judicial proceedings should be conducted. The recent difficulties with the pandemic have undoubtedly put on ice the reforms to our system of taxation as proposed by the Scottish Government and to be implemented by SCTS. It will be impossible to replicate the vast experience held by the current Auditors of Court and you, in particular. I value greatly the contribution you personally have made to the justice system since 1991.

However, this may be the right time to consider a transition to the new system perhaps by the end of this year.

As ever I would be grateful for your observations.

As mentioned briefly on the phone, I believe that the time has come for me to resign from the position of Joint Auditor, and I have written to the Sheriff Principal accordingly. The present arrangement was formalized as far as the firm was concerned by a letter to me from Kenneth McGowan, then Managing Partner, dated 18 August 1997, by which I was to continue to introduce new business to the firm, following retirement on 31 October of that year, and in exchange I could use the firm's facilities with the Document Exchange and have the occasional use of the Boardroom for oral taxations.

This has worked splendidly as far as I am concerned, and I am very grateful.

Thank you for your letter of 20 August 2021. I am happy and relieved to hear that you are now at home and recovering from your period in the Western General with Covid. I hope you continue to make a good recovery.

The virus will undoubtedly have had an impact on your wellbeing and energy and I fully understand that you should not accept any further remits and focus if you can, on "tying up loose ends" as you put it. In particular, I notice that you still have some taxations to schedule. I certainly would not want you to feel under pressure to deal with these taxations if you are still feeling under par. I will leave it to you to decide whether you wish to complete these taxations. However, I think, it is important that you know that there are other options, and if you feel that, you cannot complete these taxations, I would suggest firstly, that you contact your colleague Frank McConnell, in case he can fit them in, failing which, any accounts and any associated papers should be returned to the Sheriff Court and arrangements will be made locally to have these taxed perhaps by SCTS personnel who have already been appointed as Auditors in other Sheriffdoms. I would not want you to be struggling to fulfil these obligations if you are unwell.

I am extremely grateful to you for the service you have given to the justice system and having regard to what you say in your letter I think it may be appropriate to agree that I will accept your resignation as Joint Auditor effective from the end of October 2021 coinciding with Frank's resignation.
